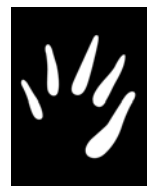

My background and experience around the world has required and developed high-level policy and analytical skills. I have a strong understanding of government administration, legislative review, analysis and inquiries generated through involvement in or management of the Australian Regional Forest Agreement process, Parliamentary and Government inquiries, Coronial inquiries and public submissions on water pricing, access and use rights and native vegetation legislation in Australia and fire and natural resources laws, regulations and policies in Indonesia, Vietnam, Thailand, South Africa and Malaysia.

I have a strong capacity to prepare, or lead the compilation of, thorough and well-structured reports along with extensive experience in review of major projects, activities and programs to analyse the need and options for change or confirm existing approaches.

I am an effective technical, management and policy specialist with over 20 years of operational, management and policy experience in natural resources management. My record of success in improving organisational structures, training frameworks and delivery, and policy evolution, demonstrates my ability and skills in leading multi disciplinary teams. I have excellent knowledge and understanding of global fire and forest management and have contributed extensively to the discussion of both globally through the Convention of Biodiversity, the United Nations Forum on Forests and its predecessors. KEY SKILLS AND EXPERIENCE:

I have 20 years of operational, management and policy experience in natural resources with an emphasis in forest fire including advice and technical assistance to fire management agencies and the private sector in the United States, China, Indonesia, Vietnam, Thailand, Portugal, Greece and Australia. Key Specialities include:

- ◆ **Natural Resources Policy formulation and implementation**, the implementation of policy at national, provincial and local scales (Water access and use management, Australia; Prescribed fire use and planning Australia, China, Thailand, Mediterranean). My particular interest is in the institutional elements of policy formulation, policy acceptance and delivery applying inclusive participatory approaches based on a jointly developed understanding of the policy context.
- ◆ **Project Management** Fifteen years experience in projects and programmes for forest fire training, forest planning (resource allocation, forest capability and land use assessments), analyses of natural resources use (water, forests) and mid-level management capacity building (forest fires South East Asia) of up to four high level teams.



- ◆ **Building Capacity in Institutions** I have built or re-built teams and sections of organisations as team leader in Fire Management, Natural Resources Planning and Policy, Community training program development and Strategic Planning. I emphasise an approach built on learning teams, logical planning and financial framework tools and participatory methods for stakeholder engagement.
- ◆ **Training and facilitation** I formulated the framework for fire management training and supported the integration of it into a national training structure. Also conducted the delivery and facilitation of training to a wide range of participants and teaching at undergraduate and postgraduate level in fire management, fire ecology, policy and oral history.
- ◆ **Forest Fire Management, planning, policy and analysis** of policies, procedures, training and standards of fire management for agencies, companies, communities and provinces (Australia, Thailand, Vietnam, China, Mediterranean). I pursue a partnership in context approach with a record of success in improving organisational structures, training frameworks and delivery and policy evolution. I have strong experience in implementing research into operational practice and the role of professionals in organisations.
- ◆ **Forest Fire Suppression Operations**, including both line and management roles in large fire suppression (fires over 1000 hectares) and fire management over 14 years in Australia (severe fire seasons 1983, 1985, 1988, 1991, and leading the State Forests fire management effort during the severe fires of January 1994) and advice on methodology, techniques and technical requirements (United States, Portugal, Thailand). I particularly focus on turning existing capacity and community based methods to fire prevention, planning, management and suppression. I advocate and undertake intense scrutiny of proposals for imported technology, approaches or methodologies finding they are generally ill advised, inappropriate and unmanageable (Aircraft/Satellite imagery - Australia, Indonesia, China; Portugal).

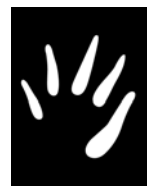
